The OSTA Transformation Project

The Ottawa Student Transportation Authority delivers transportation services to students of the Ottawa-Carleton and Ottawa Catholic School Boards in a safe, efficient and effective way.

The Ministry's Effectiveness and Efficiency Leading Practices Guideline outlines all the goals and strategies each student transportation consortium is expected to meet and is available on OSTA's website at http:// www.ottawaschoolbus.ca/images/documents/med-effectiveness-efficiency-report-2013.pdf.

Key Elements for Routing Efficiency

- 1. One set of walk zone maps using the same distance measurement for both school boards, and which include a standardized set of walking hazards.
- 2. Establishing school bell times that allow each bus to service up to 3 schools within geographical areas, whenever possible and regardless of school board.
- 3. Reducing the number of kilometers run by and paid to Operators.

Student Active Transportation (SAT) Program

Did you know that walking to school improves students' health and ability to learn? Student well-being is of great concern to the OCDSB and OCSB, and through their School Active Transportation Charter, they have committed to providing resources from OSTA's SAT program.

OSTA works with its Member School Boards, Ottawa Public Health, Green Communities Canada and its City of Ottawa partners to deliver services that assist students who walk, bike and roll to school. This coming Fall, OSTA will be participating in a Walking School Bus Pilot to evaluate the benefits and costs of having paid WSB Leaders lead groups of children to school using a pre-determined route.

Upcoming Consultation

The consultation schedule for schools where significant change is proposed is posted on the OSTA website. Each session presentation is identical, so you may choose to attend another consultation session that is convenient for you. However, walk zone maps for your school will only be presented and discussed at your school's scheduled consultation session. Any schools NOT appearing in the consultation schedule have either no or very low impact with proposed changes.

- 3. Give specific information about the concern—For example, if you can't make your OC Transpo bus with the new time, include the bus route number so we can look at it.
